Clinical Duties: BBRP OR Rotation

1. The fellow will provide direct patient care in the Pediatric OR at the University of New Mexico 4 days a week for at least 7 months.
2. The fellow will be available for pediatric call from home 2 nights per week.
3. Duty hours will be limited to 80 hours per week, averaged over a four week period, inclusive of in-house call duties.
4. If the fellow works past midnight, he/she will be given the following day off.
5. The fellow will have at least 10 hours off between going home at night and returning the next day for work.
6. The fellow will be required to take pediatric call from home 1 weekend per month.
7. The fellow is responsible for performing **preoperative evaluations** and **post-op checks** on all patients that he/she cares for in the OR.
8. The fellow is responsible for following the acute pain management for all patients on which he/she performs peripheral nerve blocks or neuroaxial blockade.

Administrative Duties:

1. The fellow will assist in review of all anesthesia QA forms for the pediatric OR.
2. The fellow will help compile a quarterly QA report.
3. The fellow will participate in the Pediatric QA/Morbidity and Mortality Conference.
4. The fellow is responsible for recording all cases he/she performs during the fellowship and maintaining the electronic case log.

Scholarly Activities/Education:

1. The fellow is responsible for preparing and presenting 3-4 pediatric lectures per year
2. The fellow is responsible for participating in the monthly pediatric journal club.
3. The fellow will produce 1 case report or abstract per year.
4. The fellow will participate in a research project. The project should be completed prior to the completion of the fellowship.
5. The fellow will be given 1 non-clinical day per week for reading, research, and maintenance of the learning portfolio.
6. The fellow will attend all pediatric lectures and 75 % Fri. AM departmental grand rounds.
7. Simulation sessions 2x/year

Rotations Outside the BBRP OR:

1. The fellow will have at least 1 month of critical care service in the PICU or NICU.
2. The fellow will do 2 months of pediatric hearts at an accredited program.
3. Additional rotations are available in acute pain-regional anesthesia/PACU, palliative care or research.

Assessment:

1. Assessment will be ongoing throughout the 12 month fellowship.
2. When working in the OR, the supervising attending will give daily verbal and written formative feedback.
3. The fellow will be evaluated monthly using the new innovations global rating tool.
4. All didactic presentations will be evaluated using the standardized lecture evaluation form.
5. The fellow will receive a monthly verbal performance review and receive a summative written performance review addressing each competency every 6 months. This evaluation will be completed by the program director.
6. The fellow will be asked to select 2 charts quarterly for chart stimulated recall and questioning. Written formative feedback will be given for the CSR session.
7. A 360 degree evaluation will be performed every six months to help assess communication skills and professionalism.
8. A final summative written evaluation will be completed by the program director at the end of the twelve month fellowship.
